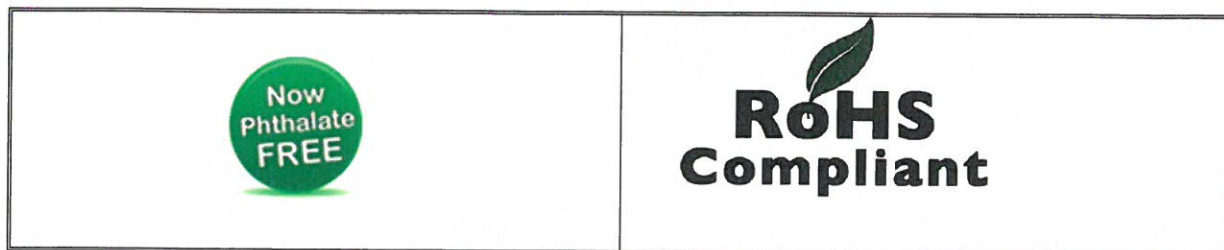

Regulation (EC) No. 1907/2006 concerning the Registration, Avaluation, Authorisation and Restriction of Chemicals (REACH).

Hereby we inform that our standard products are developed and produced with the European Union Regulation No. 1907/2006 (REACH, Registration, Evaluation and Authorisation of Chemicals).

To our current knowledge and based on the information received from our suppliers, we confirm that all our parts are in compliance with European Union Regulation No. 1907/2006 and do not contain any of the 174 Substances of Very High Concern (SVHC) of the last ECHA-list in a concentration above 0,1% (w/w).

We are in constant contact with our suppliers. If we receive a notification that an article exceeds the allowed limits, we will immediately inform customers concerned to article 33.

Directive 2011/65/EU on the restriction of the use of certain hazadous substances in electrical and electronic equipment (RoHS 2)
